### A message from Squarespace:

"This website is hosted by Squarespace. Squarespace collects personal data when you visit this website, including:

Information about your browser, network and device

Web pages you visited prior to coming to this website

Your IP address

Squarespace needs the data to run this website, and to protect and improve its platform and services. Squarespace analyzes the data in a de-personalized form."

#### What data we collect:

LVS collects & stores the following data in a secure database:

- Personal identification information (Name, E-mail Address, & Telephone number).
- For accounting purposes we also record the Company Name/Facility Name & Address (geographic location) that is requesting services.

The LVS website collects personal data to power the site analytics, including:

- Information about your browser, network, and device
- The web page you visited prior to coming to the LVS website (what link was clicked on)
- Your IP address

This information may also include details about your use of this website, including:

- Clicks
- Internal links
- · Pages visited
- Scrolling
- Searches
- Timestamps

LVS shares this information with Squarespace, our website analytics provider, to learn about site traffic and activity.

#### **How we collect your data:**

You directly provide LVS with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback.
- Use or view our website via your browser's cookies.

#### How we use your data:

LVS will not share your personal information to a third party without consent unless instructed to by law. We will never sell your data. LVS collects your data so that we can:

- Process orders and manage your account.
- Email you with test results/project reports, project updates, information, research updates, and service availability or other information on services we think would be of benefit to you.
- Improve our performance & services.

#### How long we store your data:

Because LVS performs research & monitors plant pests & diseases over very long periods of time (years to decades) LVS will keep your Name, (work) Address, (Work) Telephone & (Work) E-mail contact details on file unless you wish to exercise your right to be forgotten. For accounting & legal purposes personal data will be securely stored for the minimum period of 7 years. Once this time period has expired, we will delete your data by shredding paper files, and electronically anonymise your personal information in our central database unless you are an ongoing active client.

## Marketing:

LVS would like to send you information about our latest research & packages that we think would be of benefit to you. We share your contact information with our website service provider, Squarespace, to facilitate email campaigns & automated messages when you create an account, create or change a password, or make a purchase.

If you have agreed to receive marketing, you may always opt out at a later date. Please note that it is not possible to unsubscribe from emails which inform you that you have created a Customer Account, if your password has been re-set or updated, if you make a purchase, & notification of results/reports.

You have the right at any time to stop LVS from contacting you for marketing purposes. If you no longer wish to be contacted for marketing purposes, please contact deborah@laganvalleyscientific.com or click the 'unsubscribe' link in the email received.

#### What your data protection rights are:

LVS would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

**The right to access** – You have the right to request LVS for copies of your personal data. We may charge you a small fee for this service & require proof of identity to release personal data.

The right to rectification – You have the right to request that LVS correct or update any information you believe is inaccurate. You also have the right to request LVS to complete the information you believe is incomplete.

**The right to erasure** – You have the right to request that LVS erase your personal data, under certain conditions.

**The right to restrict processing** – You have the right to request that LVS restrict the processing of your personal data, under certain conditions.

**The right to object to processing** – You have the right to object to LVS's processing of your personal data, under certain conditions.

**The right to data portability** – You have the right to request that LVS transfer personal data that we have collected to another organisation, or directly to you, under certain conditions.
